I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ANY/ALL ACTIVITIES ASSOCIATED WITH CLUB TRAIL MAINTENANCE OR EVENTS including by way of example and not limited to, any risks that may arise from negligence or carelessness on the part of the persons or entities, be released, from dangerous or defective equipment or property owned, maintained or controlled by them, or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently prepared or trained for participation in this activity and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in this activity.

I acknowledge that the event holders, sponsors and organizers of the activity in which I may participate will use this Accident Waiver and Release of Liability Form and that it will govern my actions and responsibilities at said activity.

In consideration of my application and permitting me to participate in this activity, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors and assign as follows:

- A. I WAIVE, RELEASE AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the St. Germain ATV Club Inc. and its Officers and Directors and Volunteers, for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter occur to me including my traveling to and from this activity, THE FOLLOWING ENTITIES OR PERSONS, the St. Germain ATV Club Inc. and/or their Directors, Officers, employees, volunteers, representatives and agents, and this activity whether caused by negligence of release or otherwise.
- B. I DEMNIFY, HOLD HARMLESS AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any, and all, liabilities or claims made because of participation in this activity, whether caused by the negligence of release or otherwise.

I acknowledge that the St. Germain ATV Club Inc. and their Directors, Officers, volunteers, representatives and agents are NOT responsible for the errors, omissions, acts or failures to act of any party or entity conducting a specific activity on their behalf. I acknowledge that this activity may involve a test of the person's physical or mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, lack of hydration and actions of other people including, but not limited to, participants, volunteers, monitors and/or producers of this activity.
